

America in World War II and Korea, James Fiorello

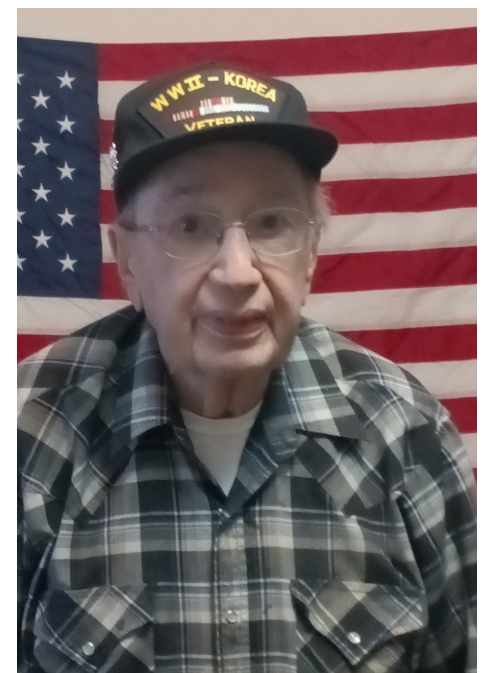
Hailing from the long-gone Boston neighborhood, once known as the West End, Methuen's James Fiorello graduated from Boston's Mechanic Arts High School with the class of 1941. He then enrolled at Fitchburg State College,

with the intent on becoming a teacher. The Japanese attack on Pearl Harbor on December 7th changed the career plans for him and the sixteen million young Americans who served in World War II. The population of the United States in 1941 was one hundred and thirty-two million. Nearly twenty percent of all Americans alive on December 7th,

served in the US Military during World War II.

Commissioned an Ensign in the US Navy, he was assigned to the USS Bexar (APA-237/LPA-237) a Haskell-class attack transport in service with the United States Navy from 1945 to 1970. He joined the crew as the ship embarked on her first deployment to the Pacific, as part of "Operation Magic Carpet." James and the ship's crew was tasked with returning US troops from the Pacific Theater, back to the United States, until February 1946. One of James's most vivid war memories was spending Christmas 1945 in bomb damaged Tokyo Bay. He said, "I have no bitterness towards the Japanese people, it was their leadership that started the war and continued fighting the war after it was lost."

James also has very fond memories of liberty in San Francisco, California in 1945, prior to deploying to Japan. He said, "The restaurants in San Francisco at the time, were beyond words, outstanding." Returning from transport duty, the ship's crew had a brief tour of duty around San Diego, during the early part of 1946. The ship was then ordered to Pearl Harbor to prepare for Operation Cross-Roads. Crossroads was the historic event on Bikini Atoll, designed to test the effectiveness of the atomic bomb on warships. Over two hundred warships participated in the operation, seventy-five of them as targets. James's ship, the



Bexar, served as the test's equipment supply center.

After the war, James completed his BA with Fitchburg State. He then completed his MA at Springfield College. Finally earning a Doctorate in Education at the University of Connecticut. When North Korea invaded South Korea on June 25th, 1950, James, then a US Naval Reserve Officer, found himself back on active duty. He was re-assigned to serve once again on the USS Bexar, a ship named after Bexar County, Texas. During July 1950, the USS Bexar departed

End Attorney Immunity

To END attorney Immunity in MA support Senate Bill S.1131 'An Act to strengthen rules governing attorney conduct; penalties for misconduct'. malegislature.gov/Bills/193/S1131

Attorney immunity protects attorneys from civil liability. Immunity given to attorneys is a privilege that makes it impossible for litigants to obtain fair and equitable treatment in court.

If you agree that attorneys should be accountable for their fraudulent actions during judicial proceedings, contact the Judiciary Committee to pass S.1131 to end attorney immunity and require attorney conduct to be regulated and punishable by the state. It is time for Massachusetts citizens to have the same protection and remedies as several other states: Ark., Cal., Ind., Iowa, Minn, Mont., N.Y., N.C., N.D., Okla., S.D., Wyo. These states do not give absolute immunity to attorneys who commit judicial misconduct; these states do permit civil actions that allege attorney acts of fraud, intentional misrepresentation, deceit or collusion meant to deceive the court or any opposing party:

No legitimate purpose is served by granting attorneys litigation "immunity" either absolute or qualified; it is an unjustified protection for the unworthy.

Litigation immunity undermines the legitimacy of the country's legal process and constitutional protection.

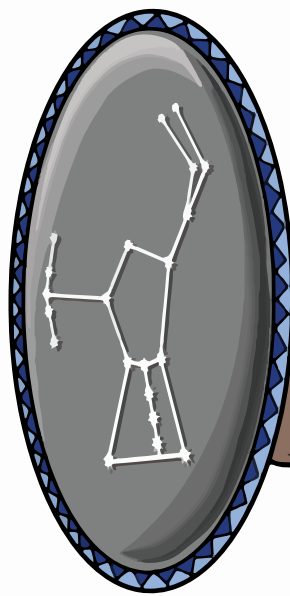

Lawrence Council Approves Bus Station Use for Homeless Dinners

Last month, the Lawrence City Council voted 8-1 in favor of allowing weekly homeless dinners to continue at the Buckley Garage on Common Street.

The dinners are sponsored by a local non-profit called The Movement Family (or TMF) every Wednesday evening at 9pm. The dinners took place for two years before the previous mayor, Dan Rivera, put a stop to it saying that TMF was using a city-owned property, and that they were using the property without a legal permit to do so.

TMF appealed the mayor's ruling by applying for a permit and appearing before the City Council but was rejected by a vote of 5-4.

When Mayor DePena took office two years ago, he made good on his campaign promise to allow TMF to return to the Buckley Garage as long as they applied for a permit, and got approval of the council, which they did. The two-year permit was set to expire in April of 2024.

Last month, TMF founder Michael Gorman filled Lawrence City Council Chambers with supporters and who spoke to advocate for TMF to have their permit to be renewed.

State Representative Francisco Paulino took time from his duties in Boston to speak before the council, saying that TMF's efforts to feed and clothe the homeless is making a significant difference in the community. He pointed out that not only do they provide a meal for the homeless once a week, but partner up with outside organizations like Tewksbury Detox to get them clean and put them in transitional housing. Paulino



also talked about how he grew up poor and had no food when he was younger, adding that he wished that he had TMF back then when he would sometimes go days without eating.

Lawrence City Councilor Maria De La Cruz, (who was the decided vote against TMF when Rivera was mayor), spoke at public participation thanking TMF for the work they do in the community, singled out Valley Patriot publisher Tom Duggan, and announced that she would be voting to support TMF's permit extensions.

When it was all over, the council voted

8-1 in favor of renewing the permit for TMF until April of 2026.

"This was a huge win for us," TMF founder Michael Gorman told The Valley Patriot to thunderous applause in the City Hall lobby after the vote.

"First, we need to thank The Valley Patriot and all their readers and supporters of Facebook who made calls and wrote letters, and make donations to TMF every single week. The Valley Patriot is the reason we are here at city hall tonight and this win could not have happened without Tom and his readers."

"I also want to thank the Lawrence

firefighters for making calls and writing letters, as well as Mayor DePena, Octavian Spanner, the city councilors, and everyone who stood by us."

"It is so crucial to show these individuals on the streets who might be addicted, or in a dark place, that there is somewhere to go not just for a meal but for help, and services, and love," Gorman concluded. "Lawrence officials sent a very powerful message that the city cares about everyone, not just those who make campaign contributions - and there's something wonderful about that." ◇

Raising the Bar on Education

The Crucial Need to Increase the Dropout Age

As a State Senator, my commitment to improving education in Massachusetts is unwavering. Senate bill 341, "An Act Relative to Dropout Prevention and Student Recovery," a pivotal piece of legislation, which I sponsored, aims at reshaping the educational landscape for our students. The primary goal of this bill is to elevate the age at which a student is permitted to leave school to 18, and to introduce a pilot program targeted at districts with dropout rates exceeding the state average. The vision behind this legislation is simple yet profound: ensuring that all our students have the tools and opportunities to earn their high school diploma.

Our state has witnessed considerable progress in reducing the dropout rate over the past decade. However, we must acknowledge that certain groups of students still face alarmingly high dropout rates. Data compiled by the Department of Elementary and Secondary Education (DESE) for the 2021-2022 school year uncovered troubling statistics. It revealed that 2.8% of Black and 4.3% of Hispanic or Latino students dropped out of high school, significantly higher than the statewide rate of 2.1%. The discrepancy becomes even more glaring when we look at Limited English Proficiency Learners (LEP), whose dropout rate stands at a

staggering 7.8%, almost four times the statewide average. We must take concrete steps to ensure that every student, regardless of their racial, socioeconomic, or cultural background, is given the support and resources necessary to earn their high school diploma.

One crucial aspect of this legislation is raising the dropout age to 18. Our school districts should not be giving up on students during early high school years when students typically reach the age of 16. By extending the mandatory school attendance age to 18, we are sending a clear message that we believe in every student's potential and that we are committed to supporting them until they successfully complete their high school education.

But this bill is not just about raising the dropout age; it also introduces a pilot grant program designed to provide districts with the resources they need to keep students in school. This program focuses on districts with dropout rates higher than the statewide average, aiming to target students who have already dropped out or are at risk of doing so. It stipulates that the program must employ at least one of four methods known to be effective in helping students stay in school.

These methods encompass alternative education strategies, graduation coaches, dropout outreach and recovery programs, and expectant and parenting student support. Through these approaches, we

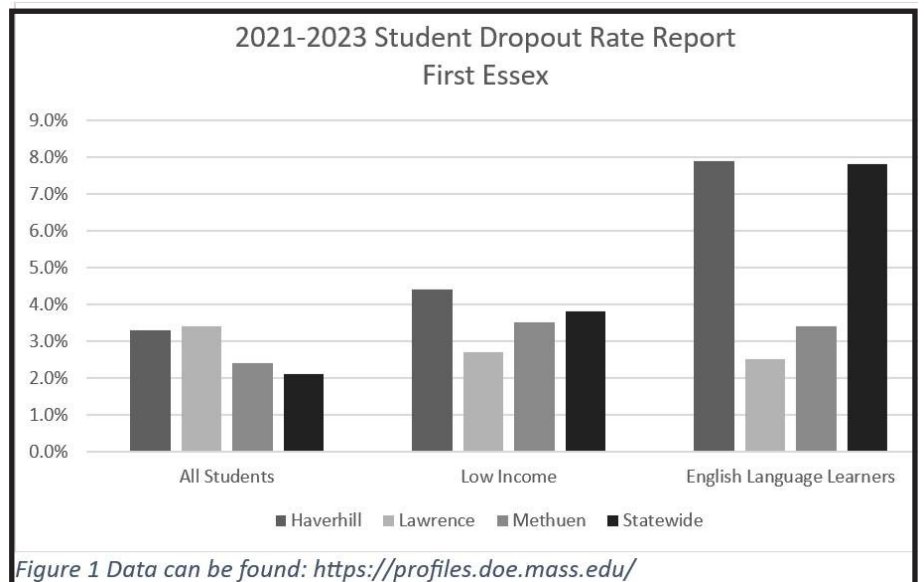


Figure 1 Data can be found: <https://profiles.doe.mass.edu/>

can better engage students, address their unique needs, and provide the support required to guide them towards their high school diploma.

Accountability is central to this bill. The Department of Elementary and Secondary Education (DESE) will be responsible for leading an annual review of the pilot program, ensuring that participating districts are making the progress we desire. Additionally, DESE will submit a final report after the three-year pilot period, featuring a comprehensive analysis of all relevant data. This analysis will help us determine the effectiveness of the program and present specific legislative recommendations. Ultimately, it will

guide us in deciding whether to expand, maintain, or discontinue the program.

In a world that thrives on innovation and adaptability, the future belongs to those who have the skills, determination, and opportunity to pursue their dreams. Success knows no bounds, and it doesn't hinge on a predetermined path, such as a traditional college education. The key is to equip every student with the foundational skills, resources, and support needed to unlock their full potential. This legislation is a crucial step toward that goal, and by raising the dropout age and implementing innovative programs, we can ensure that all students have the opportunities they need to build a successful future. ◇

Secretary of State's Office Confirms Ballots Went Uncounted in Rowley

Emails obtained by The Valley Patriot reveal that a number of voters in Rowley had their ballots discarded and uncounted in last November's election where Kristin Kassner (D-Hamilton) won the 2nd Essex State Representative seat by one vote over Lenny Mirra (R-Georgetown).

Minutes taken during the recount in that race reveal that ballots rejected by voting machines were "spoiled" by election workers and not counted in the election. This was confirmed in emails from Michelle K. Tassinari, Director and Legal Counsel at the Office of the Secretary of the Commonwealth, who states that "election workers were spoiling ballots that could not be read by the tabulator. The Town Clerk was informed that spoiling ballots that could not be read by the tabulator is NOT the correct procedure. Ballots that cannot be read by the tabulator should be hand counted not spoiled."

At the conclusion of that recount, which found no change in Mirra's four vote lead, attorneys for Kassner

demanded to view a pile of spoiled ballots.

They found ten ballots that were deemed to be improperly spoiled and pulled out five of them, all containing votes for Kassner, allowing her to win by one vote.

"We were treated rudely and unprofessionally from the very start," claims Sandra Capo, who was working at the recount on behalf of the Mirra campaign. "Trudy Reid tried to have me removed from the recount, claiming I was not allowed to work there because I was not the candidate.

I told her that Lenny is at the Ipswich recount, which was happening at the same time. I pointed out that Kassner also wasn't at Rowley because she was also at the Ipswich recount."

Reid, who apparently has a history of partisan behavior, was deputized into running the recount on behalf of the town of Rowley.

"We objected to the counting of spoiled ballots as this was not allowed at

any other recount," Capo continued. "A phone call was made to the Secretary of State's office and Trudy Reid spoke to someone there. The Secretary of State's offices will not respond to requests as to what was said, so we don't know what she was told, but we're sure Reid wasn't told to allow one side to cherry pick five ballots when their candidate was down by four votes. And yet she did exactly that."

Mirra brought the issue to court where judge Thomas Dreschler ruled the matter was no longer in the court's jurisdiction, but rather with the House of Representatives. A Special House Committee was formed with Rep. Michael Day (D-Stoneham) as Chairman. After several weeks of no action Day decided to call the election for Kassner without reviewing any of the contested ballots.

House Minority Leader Brad Jones (R-North Reading), who was on the Special House Committee, submitted bill H-53 which would have requested the House to open the disputed ballots,

but it was voted down along party lines with all Republicans voting in favor of it but all Democrats, with the exception of Russell Holmes (D-Boston), voting in opposition.

"The real problem here is Bill Galvin (D-Boston), our Secretary of State, has been completely silent on this and many other serious election issues," Mirra stated. "In addition to Rowley we had over a dozen ballots magically appearing at the recount in Ipswich that were not counted during the election. We also had over a hundred mailed-in ballots arriving in Ipswich after the election where signatures on envelopes did not match those on applications.

"This also happened in the 1st Middlesex race between Margaret Scarsdale (D-Pepperell) and Andrew Shepherd, where signatures on mailed in ballots did not match those on applications. Apparently, Galvin is perfectly fine with these problems as long as they benefit him and his party."

Massachusetts General Law, Ch. 54, Section 103 states that "the Supreme Judicial and Superior Courts shall have jurisdiction in equity to order the counting of any ballot improperly rejected." ◇



Reforms Sorely Needed at the Sex Offender Registry Board

Serving as Massachusetts State Auditor doesn't just mean reviewing finances. A big part of my role, as I often speak about with folks across the state, is reviewing the performance and efficacy of the Commonwealth's agencies and entities. A great example of the responsibility to look beyond number crunching is our office's recently released audit of the Sex Offender Registry Board (SORB).

People are familiar with the concept that Massachusetts registers convicted sex offenders, maintaining a database of where such people live and work in an effort to maintain public safety. This system of public safety is maintained by SORB, a seven-member board appointed by the Governor and staffed by more than 70 individuals.

Our recent audit looked at SORB's operations from July 1, 2019 – June 30, 2021. Covering that two-year period, my team honed in on whether SORB classified sex offenders at least 10 days before they were released from custody, thus ensuring they were assigned an appropriate level. Further, we looked at whether SORB used all the resources at their disposal to accurately identify sex offenders who were in violation of maintaining their registration.

I was disappointed to find that SORB underperformed in a way that could have a negative impact upon the public.

While incarcerated sex offenders are supposed to be assigned a classification at least 10 days prior to their release, per state law, SORB failed to do so with approximately 1/3 of those released during our two-year review window.

More concerning, 77 offenders didn't receive their classification until after they were released.

This lax approach to the law meant those sex offenders' names, addresses, offenses, and registration statuses were not appropriately posted to SORB's website for level 2 and 3 sex offenders and were not otherwise available to the public.

Our audit team also identified other vulnerabilities regarding how SORB tracked offenders who have been released from incarceration. Namely, SORB's database was not kept up to date in all situations, with approximately 1 out of 5 offenders showing incorrect addresses when compared against records maintained by other state departments (such as the addresses the Department of Transitional Assistance records).

Part of the benefit of SORB is that it tracks the location of high-level offenders. By not ensuring that it has the current addresses of sex offenders considered in violation, SORB is not able to consistently communicate information about sex offenders' whereabouts, their offenses, and their classifications to local law enforcement agencies and the general public. What's disturbing is that some of these issues were identified the last time my predecessor audited SORB. These issues must be immediately addressed.

Our office has recommended that SORB increase their collaboration with correctional facilities to establish more reliable procedures for providing anticipated release dates for incarcerated

offenders. We've also recommended the implementation of a tracking process that identifies any delays or issues that may arise, to ensure that all sex offenders are assigned final classifications prior to each offender's release.

For ensuring residential address accuracy, SORB needs to not only work more closely with other state agencies to verify addresses – SORB must also make a point of updating those addresses in

their system when they are found.

We will continue to work with SORB and encourage their adoption of practices that maximize public safety.

Co-Sponsoring Environmental Legislation

First, I want to congratulate Valley Patriot publisher Tom Duggan who received an "Overcoming Obstacles" award from the Greater Lawrence Psychological Center last month. Given what Tom has been through, just in the last year alone, he has certainly earned this award.

I also want to congratulate Jana Zanni-Pesce on her decisive election win to the Methuen City Council, I am sure that Jana will serve the people of Methuen quite well over the next two years and I look forward to working with her.

As for what's going on in state government, protecting our environment has been a main focus of the legislature this session as well as working with local unions, and "equitable work."

As your state representative, I support policies to ensure a clean environment and growth in renewable energy careers.

There are three house bills that address this topic and I have co-sponsored these bills in hopes of creating more jobs that

will support clean energy and better schools. They are:

H.1864 An Act relative to clean energy workforce standards and accountability

This bill ensures energy construction and infrastructure projects are sufficiently staffed with highly qualified workers. It also ensures projects create quality, family-sustaining jobs through the application of the state's prevailing wage laws. The goal of this legislation is to transition workers in fossil fuel-intensive industries to jobs in clean energy and protect their incomes and benefits through that transition.

H.1865 An Act relative to a just transition to clean energy

This bill provides training and employment opportunities to former and current energy workers being displaced. It will increase opportunities in the clean energy sector for residents of environmental justice communities. There will be benefits for workers who are displaced from the transition to clean energy jobs.

An environmental justice community is a community that is subject to a



disproportionate burden of environmental hazards. The district Rep. Reyes represents the 4th Essex District, falls in that definition of being an environmental justice community, and would benefit from worker training and protections.

H.3691 An Act relative to healthy and sustainable schools

This bill will prioritize schools in environmental justice communities for implementing energy efficiency improvements and installing renewable energy systems. It will create an office to focus on schools' efficiency improvements through enforcing contract requirements. One focus will be to hire from environmental justice communities and to comply with the state's goal of hiring women, minorities, and veterans. Funding for this bill will be pulled from state agencies and federal environment-friendly sources.

H.444 An Act to expand the use of career and academic plans

This bill will ensure all high schools across Massachusetts participate in

MyCAP by 2026. MyCAP, my career and academic plan, is a whole-school system that allows students to develop individualized college and career plans with the assistance of a counselor. MyCAP allows students to drive their education to support their post-graduation plans. Ensuring college and career counseling in schools lessens disparities household by household.

As for my time in Lawrence and Methuen, I was pleased to be at the ribbon cutting last month for Factorial Inc., an industry leader in the development of solid-state battery technology for electric vehicles. (See page 26).

The Lawrence Public Schools got \$5,500 in state funding last month for MyCAP, a career planning program for students.

This program is connected to legislation that I am currently working on, along with Representative Cruz.

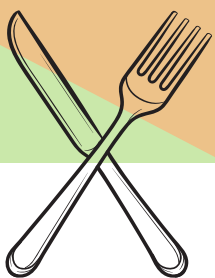

Strong town government is at the top of the list. Things have been going well in Dracut and it's not by accident. It's because the right people have been in charge of town government.

Thanks to the leadership of Town Manager Ann Vandal, who took over the job four years ago, Dracut is in better shape than it has been in quite some time. Town finances are in solid shape. School spending is on the rise. Capital improvement projects are being worked on all over town. There's continuing efforts to balance growth and development with open space, preservation, and conservation. There's an ongoing focus on economic development, including bringing in new businesses and supporting existing ones. Morale at town hall is high. People in town are optimistic about our future.

In her annual performance review in October, Vandal scored a 3.9 out of 5. Her high score from Selectmen again this year is reflective of her consistent on-the-job performance and the fact that Dracut is in good shape overall right now.

Make no mistake about it: Our success is due to Vandal's leadership, her staff of department heads, and all

the town employees. Our success is due to clear direction from the decisive majority on the Board of Selectmen. Our success is due to strong support from the townspeople. Seeing Dracut be successful as the result of strong leadership is something we can all truly appreciate.

Here's something else you may appreciate: At a recent Tri-Board meeting about town finances and potential future budget deficits with the Board of Selectmen, School Committee, and members of the Finance Committee, accusations flew, tempers flared, and emotions ran high. Vandal, on the other hand, stayed calm, cool, and collected during the discussion, telling board members nothing had changed since the previous Tri-Board meeting: town finance officials are currently estimating a \$2.2 million budget deficit for the 2025 fiscal year, but that figure is fluid and far from final. Vandal said there is no way to determine whether there will be a deficit or what the amount could be, based on the information available right now.

She refused to give into the bullying, browbeating, and belligerence from some who wanted her to name a list of potential budget cuts.

"I'm not going to sit here and say, 'We're going to do this, we're going to do that, and cut this and cut that.' I won't do that, until we have to," Vandal said.

In other words, we can also be thankful for Vandal's commonsense and patience when it comes to handling town finances and business.

A strong Police Department that enjoys strong support from the community is another blessing.

Here's one recent example: Thanks to a thorough and diligent investigation by the Dracut Police Department, organized sporting events and large gatherings have been shut down at 167 Betty Ann Lane. There's no more cheering crowds, no more cars racing up and down the street and no more illegal sales of food and beer. Instead, there's peace and quiet once again in that residential neighborhood because police investigated appropriately and solved the problem. The neighbors on Betty Ann Lane and all of us should be appreciative of the efforts by our police to resolve the matter effectively.

The police protect and serve our community in many ways. Another example is the Dracut Public Safety Night that was held in June. For the



second year in a row, the Dracut Police Department hosted an overwhelmingly successful event where hundreds of town residents came to enjoy the festivities, interact with law enforcement officials, and show their support for our police and other first responders. It was a good reminder to be thankful for the good things that happen in Dracut all year long, thanks to teamwork, public-private partnerships, and hometown pride.

Airman Jack Teixeira, A Hero to Many, a Traitor to Some

Yes, it is true that Airman Jack Douglas Teixeira of Massachusetts 102nd Intelligence Wing of the National Guard broke the US Code of Military Laws section 18 subsections 1924 & 793 (b & d) as his United States District Court Criminal Complaint states for the record from April 14th of this year, however not much is being reported about the information he leaked. Ukraine is a fascist nation due to the fact that they have founded 12

proudly Fascist parties since their independence as a violent threat to Russia next door who has had a ban on Fascist parties since Stalin. They have almost all garnered a reputation in the Ukrainian Military by most of them joining the Azov Battalion named after an old volunteer Ukrainian Nazi sympathizer militia. Altogether, their 12 parties formed a coalition known as the Right Sector. Once united, they caused the Euromaidan Uprising in 2014, & they destroyed President Yanukovich's popularity and approval rating. Eventually the violence forced Yanukovich to use the entire Ukrainian Military to regain control of the major cities, diverting them away from the Russian border.

This made it easy for Russian forces to funnel supplies & weapons into Eastern Ukraine to arm the people for the upcoming vendetta that was sure to be imposed against Russian Ukrainians and Crimean Tartars who are one of the only minorities in Russia as Muslims in a predominantly Orthodox country. They are so respected by the international community, when the people of Crimea voted by referendum to become an Autonomous Independent Republic of the Russian Federation, the entire UN including President Obama agreed to their right to do so, but not Donetsk or Luhansk.

Now Volodymyr Zelensky is President of Ukraine, and when he took office in 2019, he made the biggest mistake of his life by denying Donetsk & Luhansk their rights to independence & self-determination by continuing the policies of President Porochenko just before

him who for 5 years had been sending Ukrainian soldiers (including the Azov Battalion) into Donetsk & Luhansk with orders to kill all separatists... thousands of Russian Ukrainian citizens have been killed in the process since 2014.

Zelensky perpetuated the killing because, desperate to join, NATO told him that Ukraine would not be able to join whilst parts of his nation were breaking away, he had no choice but to keep killing his own people in order to even have a chance of joining NATO. However, since 2014, the entire Donbas region has been known as the modern-day Stalingrad holding out against these fascists with sniper-fire depicted in the movie "A Sniper's War." Now on the front lines, due to the leaked information, since March, the Russian Army has been constantly pushing their final sweep as they scramble to hunt down and neutralize the remaining 20,000 Ukrainian soldiers in order to force NATO out of Ukraine. Within the first 3 months, Russian State Media declared that they had cut the Ukrainian military down to only 12,000 troops.

This happened to spark the recent overstated Wagner Group Rebellion led by Yevgeny Prigozhin who had been complaining for months about his group's heavy losses from achieving the result of cutting the Ukrainians down to almost nothing after man-to-man fighting on the front lines. Prigozhin only led the rebellion to secure better treatment for the members of the Wagner Group before quitting with loyal members of the group who stay with him in Belarus.

All of this recent news on the front

lines has been due to the information leaked by Airman Jack Douglas Teixeira of Bristol, MA who despite being a lowly 21-year-old Air National Guardsman, has changed history and the outcome of our generation's most pointless war. Because of him, Ukraine is down to approximately 5,000 troops by now, and that means more than 50,000 US soldiers are exempt from risking their lives in No-Man's Land... Ukraine is becoming part of Russia, and there is nothing anyone can do to stop that, so we as a country must truly prevent ourselves from getting into anymore messy unwinnable wars like Vietnam, because Ukraine is beginning to look like Saigon did in 1975. Teixeira is a hero to the people of the world and this country for saving more American lives from being wasted. He is already being hailed by Russian State Media as a hero to the people of Russia and their army. For all the crap Airman Teixeira is getting, I believe he deserves a pat on the back and a huge thank you from his fellow countrymen and the people of his community in Bristol, MA. We should all be proud of him for sharing that information as we were when Eric Snowden did.

True American heroes are the ones amongst us willing to tell the truth in order to prevent the worst possible things from happening. If he hadn't leaked the info, we Americans would be attending daily funerals for American soldiers lost in Ukraine.

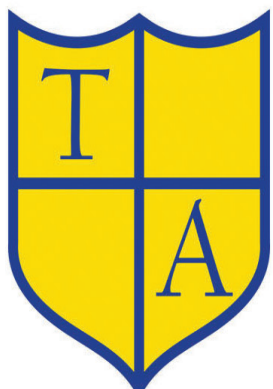

City of Lawrence Mayor Brian Depena Announces ...

EMERGENCY PARKING BAN: Alternate Parking on Certain Streets between 12:01 AM to 6AM

The winter alternate parking ordinance shall only take effect during the dates and times specified in a "SNOW AND ICE EMERGENCY" issued by the Mayor or his/her designee, The snow emergency shall remain in effect until the Mayor rescinds it. Notice of any such rescission shall be given in the same manner as the issuance of the declaration.

Winter Alternate Parking shall mean that on the following streets, between the hours of 12:01 a.m. and 6:00 p.m., daily, vehicles shall, unless otherwise prohibited by law, be parked on one side of the street only, so that on the even-numbered dates of the calendar, vehicles shall be parked on the even-numbered sides of the streets, and on the odd-numbered dates of the calendar, they shall be parked on the odd-numbered sides of the streets: **ORD 10.36.031 (*IF YOUR STREET IS NOT LISTED BELOW, NO PARKING IS ALLOWED*)**

Solomon Booked on Criminal Charges

After multiple county, state, and federal grand juries have exonerated Former Methuen Police Chief Joe Solomon on criminal charges, Methuen Mayor Neil Perry and members of the Methuen City Council were finally able to pull enough political strings to get an indictment against Solomon last month.

Oddly enough, there were no charges or indictments over a "criminal police contract" as promised by City Councilors and Solomon critics. Last month, Methuen Captain Greg Gallant won his civil service case and found not guilty of any wrongdoing regarding that police contract that city officials called "criminal".

Solomon was charged by the new

Essex County District Attorney Paul Tucker, after the former D.A. (Jon Blodgett) refused to charge him after three years of investigating.

At issue, Solomon is being criminally charged with illegally hiring former police officer Sean Fountain, even though it was Mayor Zanni who hired Fountain after a vote of the city council, a unanimous vote of the state legislature, and Governor Baker signing off on Fountain's hire.

According to the Methuen City Charter the police chief has no authority to hire police officers - that authority is left to the mayor.

Solomon is also being charged with forging Fountain's graduation

certificate from the police academy, when documents show that it was (then Captain) Randy Hagar who conducted and approved Fountain's background check, not Chief Solomon.

Hagar was then given a promotion to a newly created position of Deputy Police Chief, making almost as much as Solmon was making when he was Chief of Police. This, despite the fact that Methuen City Councilors called Solomon's salary "criminal."

As for the forgery charges, no evidence has been provided to the public or any of the previous grand juries - by any agency that has investigated Solomon - to show that he forged anything.

In fact, Fountain is actually being

charged with forging his own certificate.

Sources from the Massachusetts Police Academy have said on the record that no documents exist to show who did, and who did not graduate from the police academy making it nearly impossible to determine that Fountain did not attend the academy in the first place.

Solomon has admitted that he called people at the police academy to see if he could get a replacement certificate at the time because Fountain claimed he lost the original.

City councilors who have driven this four-year-long endeavor to get Joe Solomon charged criminally took victory laps in the Boston press after the charges were announced last month. ◊

Described as the "Creative Soul of Lowell" houses more than 350 artists under its roof (westernavenuestudios.com). Kane was very intrigued to learn more about the space because not only can you rent a working space as an artist, but you could also live in an artist loft within a community of fellow creative beings. Each artist has mastered the craft of running a small business inspired by a community that celebrates and fosters creativity.

Western Ave Studios is located in the Pawtucket Canal in a 5-building complex of 265,000 square feet of converted mill space. In 2005 Western Ave Studios opened its doors to 33 art studios and art businesses. Since 2012 Western Ave Studios is 100% occupied by art studios, businesses, and artist lofts. Kane was excited to learn that not only could you purchase art but many studios offer the opportunity to learn a craft through lessons with the resident artists. Kane always wanted to take painting lessons, so he is looking into opportunities.

When Kane arrived for open studios, it was packed. In fact, he had no



idea where he was going to park his car. What is really cool is that dogs are allowed in the buildings to visit. Open studios is an excellent way to browse the hallways to get to know the community.

For those of us that are not creative in that way, the work is very eye opening and inspiring. Kane was blown away by the number of different medias and as a side note many artists put out snacks. Kane loves snacks. He was reminded that snacks were for everyone and not

just him.

Kane visited photography studios, sculpture, painting, wood working, metal works, jewelry making, and glass blowing to name a few. Having a long tail Kane stuck to looking at the displays at Mill City Glass Works, lots of delicate and breakable pieces of art in there. Sometimes Kane isn't as coordinated as he would like to be, a German Shepherd needs to know his limitations.

Besides the artist spaces is the novel

idea of housing artists in the loft residence which affords the opportunity to work where you live in this creative community. The 50 lofts spaces range in size from 790 square feet to 1660 square feet. These are artist only spaces. Potential residents are required to document 3 years of artistic production. Resident artists display their creative works in a community gallery within the building.

There is also a gallery on the first floor of Western Ave Studios called Loading Dock Gallery. This gorgeous gallery displays an eclectic variety of different works of art by the artists that rent workspace within the studio.

Visiting the gallery and open studios is a great way to support small businesses in the local area. On his way out Kane visited the Navigation Brewery, also dog friendly, to have a beer with the local guys.

Kane plans to visit the Open Studios again on November 25th for small business Saturday for the Artist market and December 2nd for Open Studios to get some Christmas shopping done. So if supporting small business and shopping local is a priority for you come check it out. There is a lot to like about Lowell and Western Ave Studios.

Having waited 11 years to go to college because he couldn't afford it, Tom Duggan now uses the success of the Valley Patriot

to raise tens of thousands of dollars each year to give scholarships to local students.

Being the son of a Vietnam-era veteran and grandson of a WWII vet, Tom works with Clear Path for Veterans New England to get homeless veterans off the streets and provide them with needed services.

As the publisher of this newspaper, he has survived boycotts, had his character assassinated by powerful politicians, and even targeted for physical violence because of his reporting on crime issues.

If there was anyone who deserves an "Overcoming Obstacles" award this year, it is my boss - and friend - Tom Duggan who always uses the obstacles he faces to learn life lessons and then help others who have their own obstacles to overcome.

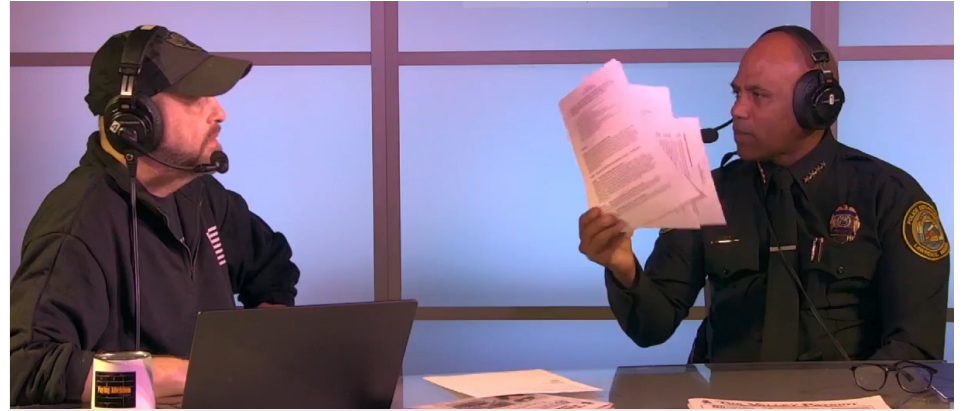

Lawrence's Record-breaking Economic Growth

For the second year in a row, Mayor Brian A. DePeña and City Councilors chose not to increase property taxes by the allowable Proposition 2.5 limitation, therefore, assuring the lowest split tax rates since 2007 and the third lowest in over two decades. The proposed FY2024 Residential Tax Rate is \$9.28; this is a decrease of \$.088 and the Commercial/Industrial/Personal Property tax rate is \$19.43; a decrease of \$1.71.

The average single-family taxpayer in Lawrence pays \$3,766 in property taxes and may potentially notice an annual property tax bill decrease of \$47 dollars. In comparison to the statewide average single-family tax bill last year which was \$6,719; this is a tax bill difference of \$2,953.

The Fiscal Year 2024 (FY2024) property assessed values for local tax purposes were approved by the DOR at its full and fair cash value. Adjustments to assessments were made to reflect changes in the real estate market and changes to the tax base due to new construction, alterations, demolitions, etc. In FY24, the total taxable valuation in Lawrence reached an all-time historic high of \$7.6B dollars; this is an increase of \$764,416,940 dollars or an 11.1% increase surpassing the previous year's record high totals. The average single-family assessed value shattered last

year's historic high valuation reaching \$405,000 dollars.

Another great news is that on October 25, 2023, the Massachusetts Department of Revenue certified that the amount of available funds, or "free cash", as of July 1, 2023, for the City of Lawrence is \$43,280,417. This is the largest free cash certified in the city's history.

Free cash results from the calculation, as of July 1, of a community's remaining unrestricted funds from operations of the previous fiscal year based on the balance sheet as of June 30. It typically includes actual receipts in excess of revenue estimates and unspent amounts in departmental budget line items for the year just ending, plus unexpended free cash from the previous year.

Also, the Lawrence Water and Sewer Department received its certified retained earnings from the Massachusetts Department of Revenue in the amount of \$3.1 million dollars.

This is a significant improvement over the last fiscal year and is great news for the city. We are excited about the progress and the future of the department.

Mayor Brian A. DePeña would like to thank all city department heads and employees for their hard work and for their stewardship in managing city funds allowing for this record-free cash certification. ◇

money to the Lowell Salvation Army to aid in their mission in surrounding communities. Five thousand dollars was raised that first day some twenty-five years ago. Warren still hosts the program on WCAP 980 AM

with Gerry Nutter and Shawn Ashe. There are many behind the scenes that make the efforts look easy. The date is December 2nd starting at 6:00 am and going until they reach their goal. You quickly learn how generous the Merrimack Valley can be.

There are few things that defy the laws of physics that become greater when they are divided. Joy and gratitude are such entities. If you give joy and gratitude to another individual, it is never taken away or lost from yourself. The best way to make two people happy is to make someone else happy. It is that simple. I believe that is what is so endearing and enduring about the story of Ebenezer Scrooge in A Christmas Carol. Through visitations of Christmas Spirits: past, present, and future. Scrooge realizes that trying to hoard what he thinks will make him happy creates misery. Only through giving of himself does he achieve true happiness and wealth.

I am grateful for the sacrifices that my parents made for me. They made do to provide what they felt their children should have: a good education and moral upbringing. I am truly humbled by their dedication and devotion to family and friends. My endeavor now is to pass those blessings along as best I can to the next generation of family, friends, and community. But for the Grace of God go I and I am unceasingly grateful. ◇

Confronting Evil in a Dangerous Time of Appeasement

The Squad—a radical cabal operating without reproach in the US House of Representatives-- is seeking a Congressional Resolution (CR) that would be equivalent to sending an unarmed social worker to resolve the genocidal actions of terrorists. Stockton Park Rededication & Unveiling Portraits

Lawrence - A special ceremony at Stockton Park (intersection of Winthrop Ave and South Union St) was held to rededicate the park in memory of Howard Stockton and to unveil five portraits of notable Lawrencians.

This project is unlike any other in the city and merges Lawrence's history with Lawrence's artists. In addition to unveiling the new Howard Stockton monument, Lawrence artists unveiled their portraits of Howard Stockton, Greg Kent, Alex Jimenez, Susan Crocker, and Abbott Lawrence.

The project was supported and co-sponsored by Mayor Brian A. DePena, City Council President Marc Laplante, and Lawrence Cultural Council Chair Patricia Mariano.

Howard Stockton succeeded Charles Storow as the Essex Company Treasurer and lived most of his life as a businessman on several boards. He also served in the Union Army during the Civil War.

Heather Langlois, the Supervisor

of Visual and Performing Arts K-12 with Lawrence Public Schools, painted Stockton's portrait.

SSgt Greg Kent (USMC), was one of our country's top runners in the 1960s and was scheduled to run in the Olympic trials, but was killed in action in Vietnam.

State Representative Francisco Paulino, who presented Kent's story commented, "Greg Kent was a hometown hero whose Olympic dreams were selflessly set aside for the battlefield of Vietnam. This portrait is a testament to history, a memorial in paint and feeling, ensuring that the tale of his bravery will forever resonate within our community's collective memory."

Stephanie Lima, an alumna from Lawrence High School and a current student at Mass Art, painted Kent's portrait.

Lesly Melendez, the Executive Director for Groundworks Lawrence gave spirited and moving comments about Sgt Alex Jimenez (USA). Jimenez

was killed in the "triangle of death" in Iraq during Operation Enduring Freedom. Alex Jimenez's father, Andy, was present and was emotional as Melendez recounted Alex's story. Sydney Susan Meas, a Junior at Lawrence High School, painted Jimenez's portrait.

Lawrence Cultural Council Chair Patricia Mariano told Dr. Susan Crocker's story. Crocker's contribution was critical in the creation of Lawrence General Hospital. Mariano went on to speak about the importance of the project at Stockton Park. "The Lawrence Cultural Council is honored to play a role in the Rededication of Stockton Park and the inclusion of five panels celebrating Lawrencians who played a significant role in the history of our city. We hope that these panels will become a living history for generations to come depicting the contributions of each Lawrencian displayed."

Finally, Lawrence City Council President Marc Laplante spoke about the Stockton Park project and then focused

on Abbott Lawrence. He mentioned that Lawrence was a businessman who helped create the Essex Company. This company purchased the land along both sides of the Merrimack River to create the dam and canals that brought hydropower to newly created mills. Through his financial contributions, he helped finance the industrial base in the city that was named after him.

Laplante also commented on the future of Stockton Park.

"This is truly a wonderful and dynamic project that will change periodically as new honorees are selected and new artists draw their portraits. These first five honorees are special as they kick off the project at Lawrence's major gateway entrance. We celebrate them and Stockton now and look forward to the project continuing and evolving with the next round of honorees and artists."

Celine Bran, a Junior at Lawrence High School, painted Crocker's and Lawrence's portraits. ♦

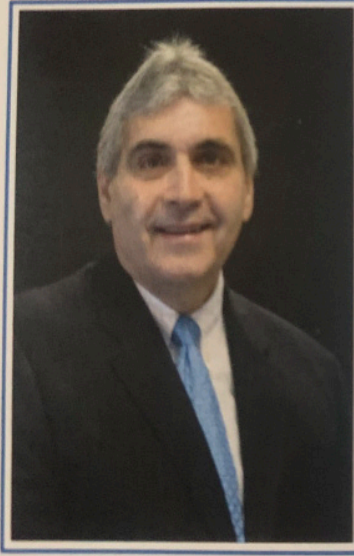

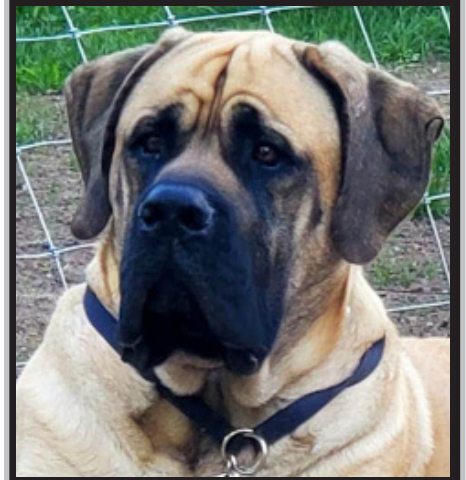
even the ACLU (when they were a legitimate civil rights organization) defended the Ku Klux Klan's right to march in Skokie because they used to believe in free speech and free expression.

A government whose charter includes exterminating Jews as their number two goal. It is a moral conundrum for sure, and when we get closer to an actual vote, I will take a position and post it online. I may even speak at the Board of Selectmen meeting if they ever have the balls to take the measure up amid all the controversy. They have already postponed the measure once; I hope they will actually schedule it for the next meeting.

Growing Up Under the Nazi Boot and the Greek Civil War, 2nd Edition

I have read both of Mr. Kakridas' book editions. The first touches on his life under occupation while the second deals entirely with his growing up under the occupation and then the civil war. With more depth and detail, I found this second edition more in keeping with the title of the book. If you are looking to read about the Nazi and civil war struggle from the author's point of view, then I would suggest this 2nd edition.

For transparency, I know Mr. Kakridas. We are both military veterans and serve in Andover's American Legion Post 8. I have also shared many events with him with and without our Legion Post. We also share a Greek background. Given our connection, I still feel I have given an impartial review.

After April 1941 life changed in Greece. For the next nine years, the country was at war. First under the German occupation and later in a bloody civil war. Mr. Kakridas does an excellent job of explaining his formative years and life in and around his small town. One can feel and see life as it appeared to this five-year-old child. The horror and confusion over why they were being attacked are also evident.

There is so much more that history's first-hand account can tell us. For example: "...the Nazis retaliated harshly against the civilian populations by rounding up women and children in the squares and torturing and brutally executing them. The Nazis ordered that ten civilians would be executed for every Nazi soldier killed. Still, when they realized this measure was not working, they raised the retaliation killings to fifty villagers for every Nazi killed by the andartes or civilians."

Time is now revealing a little-known fact about Hitler that this author mentions—that Hitler was an addict. While I did know this, what I did not know was that

his troops were also given drugs to keep them alert and active.

The staggering statistics of kidnapped children was eye-opening. It appears that this author, as well as the others in his area, were in constant fear of being abducted. Young children were routinely captured and taken to communist countries. These once-innocent souls were indoctrinated into communist theory and practice. They were then returned back to Greece to aid the communists in the country's civil war.

This author explains several times how his childhood and his life in Greece still affects him. This is apparent in his word choices. I could feel his hopelessness and despair at his lost immigration opportunity. I also felt the anger at his father for his perceived lack of help.

This book is at its best when the author recounts these personal experiences. The author's encounter with the locusts is a horror of Biblical proportions. This second edition has overcome some of the grammar and technical issues that were prevalent in the first edition, but not all.

While all the firsthand experiences were great, I could have done without the back-and-forth history. A lot of the historical facts are repeated, dates jumped around, and became confusing as times and chapters fluctuated between the Nazi occupation, and the Greek civil war.

Some passages were not clear. Ex: Amnesty Law of 1982 is mentioned at least three times without an explanation given as to what it is or what it did. At other places, paragraphs seemed out of order.

Despite some grammatical flaws, this book is well worth the read. It is a poignant, heartfelt narrative that should not be missed. I would recommend this autobiography.

WITH PAUL MURANO**

November to Remember

For Catholic Christians, November is a month dedicated to remembering the dead. While October is set aside to honor the Mother of God incarnate, November is uniquely consecrated to commemorating those who have passed on before us.

This is more than just a kind of remembrance one has for a pleasant memory or an old TV show, however. It is an interactive commemoration. From what we understand through divine Revelation, even though the souls of the dead are disembodied, they retain consciousness and identity. The human soul is subsistent as the spiritual form of the body, and hence able to survive bodily death. Yet, since we are by nature body-soul composites, the soul by itself is incomplete. After its particular judgment, the personal soul knows its eternal destiny and anticipates the resurrection of the body on the last day.

The Church recognizes the souls of the dead that have attained salvation are still alive in Christ, and remain united in charity to the Church on earth. This is because the Church is the mystical body of Christ, spiritually united to her Head by the Holy Spirit, and comprised of a three-tiered community of persons: the Church Triumphant, the Church Suffering, and the Church Militant. These are the souls in Heaven, the souls in Purgatory, and the people on earth, respectively. The relationship within and between these three tiers is not disconnected due to physical death, but united in one body by the one Spirit, just as cells are united in a human body by its soul.

Only spiritual death cuts one off from the mystical body. The spiritually dead include souls in Hell and people on earth who are in the state of sin. The latter still have an opportunity to get right with God, but those who remain unrepentant unto death choose everlasting torment due to their irrevocable decision to refuse God's offer of wholeness and joy.

The souls in Heaven need no prayers. They have claimed their reward won for them by the sacrifice of Christ. The souls in Hell also need no prayers. They have permanently rejected God's goodness, choosing falsehood and hatred over truth and love. The two tiers of the mystical body that do need prayers are the Church Militant and the Church Suffering.

Those in Purgatory have been saved by their love of God, and are 'on route' to Heaven. To apprehend the conundrum



of Purgatory, consider an analogy: A disobedient child is forgiven after being contrite for playing in the mud after being ordered by his parents not to do so. Although he's been reconciled with his parents, he's still not allowed to enter into the pristine atmosphere of the family banquet until after he serves a small punishment, takes a bath, and changes his filthy clothes.

This simple principle can be applied to the doctrine of Purgatory. Souls that are still attached to sin and haven't done sufficient penance in this life still need purgation in the next. Only with that are they fit to partake in the eternal banquet with God, the angels and saints; for nothing impure can enter the glorious gates of Heaven and experience the fullness of the beatific vision.

November, therefore, is the month Catholics set aside to honor the souls in Heaven and to pray for those in purgatory. The first two days – All Saints Day and All Souls Day – set the stage for a month of prayer and reflection. Since the three tiers are united in Christ, we all can benefit from each other's prayer and charity. This is the spiritual order of the mystical body ordained by God.

So pray for your dead loved ones. If you're convinced they're in Heaven, ask for their intercession. If you want to play it safer and assume they're in Purgatory, pray for their release. This month reminds us that love conquers death, earthly life is short, and what really matters is the eternal destiny we choose by how we love God seek to do His will.

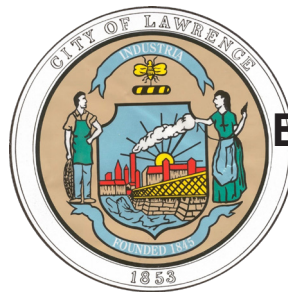
Me: Can I take Prozac too?

“Tacoma FD”

My recommendation this month is a show that you most likely have never heard of. That's probably because it airs on TruTV, a channel you also most likely have never heard of. But if you are looking for a quick binge watch that will make you laugh, then 'Tacoma FD' is the show you should be watching.

Now with 4 seasons under its belt, 'Tacoma FD' is the outrageous comedy developed by two members of the Broken Lizard Troupe: Kevin Heffernan and Steve Lemme. The Broken Lizard comedy troupe is responsible for the 'Super Troopers' films.

The show follows the daily lives and antics of Chief Terry McConky (Heffernan), Captain Eddie Penisi (Lemme) and the daytime crew at a firehouse in one of America's wettest cities. Being in one of the rainiest cities in America, leaves lots of time for its resident firefighting team to goof around, pull pranks, ramble on about nothing in particular for extended stretches, and indulge in completely juvenile humor.

With the two co-creators taking the roles of the fire station's two higher-ups, there are a bunch of other hilarious characters to round out the cast. First up is Granville "Granny" Smith (Marcus Anderson), who's possibly Tacoma FD's most logical and pragmatic character, never quite letting laughs override responsibilities.

On the flip side is the completely illogical and radically impulsive Ike Crystal (Gabriel Hogan.) Ike rocks the show's best physique, which ties into his other job as a male stripper, but he also has a heart of gold. Ike is quite fond of Andy (Eugene Cordero.) Andy takes the most razzing and ribbing, and he's an admittedly worthy target, while he's there.

Andy's character left the show following season 3 and was replaced

in Season 4 with the probie Andres Mickleberry (Christopher Avila). Rounding out the crew is Chief McConky's daughter Lucy (Hassie Harrison) and although she provides a counterbalance to the male frat boy humor in the show, she can joke right along with the rest of the crew, and provides some really funny moments.

While this show centers on firefighters, it certainly doesn't show any disrespect to the profession. "It's 90 percent about the firefighters' downtime," Lemme said.

"These guys are great at their jobs; we don't want Tacoma firefighters to think we're poking fun at their level of skill." In fact, Heffernan got a lot of ideas about funny things firefighters do from his brother-in-law, a firefighter in Connecticut, and now a consultant on the show. For example, in one episode, the characters use the Jaws of Life to play Jenga with big pieces of wood.

There are also plenty of plain old gags. In one episode, Heffernan's Chief Terry McConky, sits down to discuss serious city business with a Tacoma City Councilwoman. Then she notices a mug sitting on his desk that says, "No. 1 Farter."

Think of the humor of such movies as 'Animal House,' or 'Caddyshack' and change the location to a firehouse and you'll get the idea of what 'Tacoma FD' is all about. With bad news around every corner these days, sometimes it's good to just put something fun and mindless on TV and just laugh. This show will do that for you.

Don't Be Afraid to Scatter!

Greetings and God Bless you all in the wonderful name of Jesus Christ! I pray that you all are doing well and are ready to receive another Word from our Heavenly Father.

We read in Acts 1:8, the following, "But you shall receive power when the Holy Spirit has come upon you; and you shall be witnesses to Me in Jerusalem, and in all Judea and Samaria, and to the end of the earth." NKJV. These instructions were given by Jesus to His Apostles whom He had chosen, on the Day of the Ascension, some 40 days after His Resurrection from the dead. Which by the way, was another 5 years or so, making it approximately 10 years before the Gentiles were brought into the church after the original instructions given by Jesus in Acts 1:8.

The Church then was too comfortable and playing safe as is the Church today, which is too comfortable and playing safe! We love being in our comfort zone! We love staying where we are, where it is safe, and within our 4 walls. We love our denominations and our doctrines, we love being under the protection of our walls and our way of doing Church!

Didn't we learn anything from Covid? Church online grew like never before and Church became outside its 4 walls. After all, The Church is the people, not walls, or its flavor of doctrine. The Church in all actuality was never meant to be comfortable. The Church of Jesus Christ is supposed to experience growing pains. It is to be constantly on the move sharing the Gospel, the Good News, and pointing people to Jesus Christ! The Apostle Paul wrote in Galatians 4:19,

"My little children, for whom I labor in birth again until Christ is formed in you," NKJV. The Apostle Paul compared sharing the Gospel of Jesus Christ with the Galatians with birth pains. If I remember correctly, there was nothing comfortable about watching my wife give birth to our children. I think that she would agree with me, especially since she was the one giving birth, although, these were beautiful moments for our family. Isn't this what Jesus told His disciples to do in Matthew 28:19, "Go therefore and make disciples of all the nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit," NKJV. This is the Great Commission!

It is repeated in the Gospel of Mark with more details, Mark 16:14-18, "And He said to them, "Go into all the world and preach the gospel to every creature. 16 He who believes and is baptized will be saved; but he who does not believe will be condemned. 17 And these signs will follow those who believe: In My name they will cast out demons; they will speak with new tongues; 18 they will take up serpents; and if they drink anything deadly, it will by no means hurt them; they will lay hands on the sick, and they will recover." NKJV.

And there is more..., in Mark 16:19-20, "So then, after the Lord had spoken to them, He was received up into heaven, and sat down at the right hand of God. 20 And they went out and preached everywhere, the Lord working with them and confirming the word through the accompanying signs. Amen." NKJV. They preached everywhere and The Lord worked with them!
